

CONTRACT AGREEMENT


THIS AGREEMENT, made this 10th day of December, 2020 between MUNICIPALITY OF LAUR of the Philippines (hereinafter called 'the entity') of the one part hereinafter called the "Entity" and DAHONG PALAY PUBLICATION, CABANATUAN CITY (hereinafter called the "Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Publication of Municipal Ordinance of Municipality of Laur**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three hundred thousand pesos (PhP 300,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules as required by the 2016 revised Implementing Rules and construed as integral part of this Agreement, viz.:
 - i. the Schedule of Requirements;
 - ii. the Technical Specifications;
 - iii. the General and Special Conditions of Contract;
 - iv. the Supplier's Bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents/statements submitted ;
 - v. the Bid Form
 - vi. the Performance Security; and
 - vii. the Entity's Notice of Award.
3. In consideration for the sum of Three hundred thousand pesos (PhP 300,000.00) or such other sums as may be ascertained, Dahong Palay Publication agrees to Contract of Agreement in accordance with his/her/its Bid.
4. The Municipality of Laur agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
