

Form of Contract Agreement

THIS AGREEMENT, made this 14th day of August, 2019 between Municipality of Laur represented by the Municipal Mayor hereinafter called the "Entity" and ST. ANDREW PUBLISHING HOUSE, # 369 CULIANIN, PLARIDEL, BULACAN hereinafter called the "Supplier".

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Purchase of ICT Books use in DEP ED Laur District at Laur, Nueva Ecija** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four hundred ninety-six thousand three hundred twenty pesos (Php 496,320.00)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Invitation to Bid;
 - (c) Abstract of Canvass;
 - (d) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (e) Eligibility requirements, documents and/or statements;
 - (f) Performance Security
 - (g) Notice of Award of Contract and the Bidder's conformed thereto;
 - (h) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Supply and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
