

Form of Contract Agreement

THIS AGREEMENT, made this 16th day of November, 2020 between Municipality of Laur represented by the Municipal Mayor hereinafter called the "Entity" and BRIXON JOHN IVAN GENERAL MERCHANDISE, CABANATUAN CITY hereinafter called the "Supplier".

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Purchase of photocopying machine and printers for easier reproduction of learning materials at Laur, Nueva Ecija** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Five hundred four thousand one hundred twenty pesos (PhP 504,120.00)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted ;
 - (b) the Schedule of Requirements/Bill of Materials;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy any defects therein in conformity with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


